

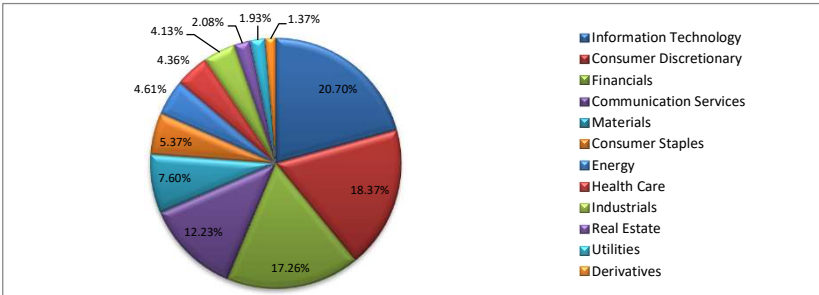

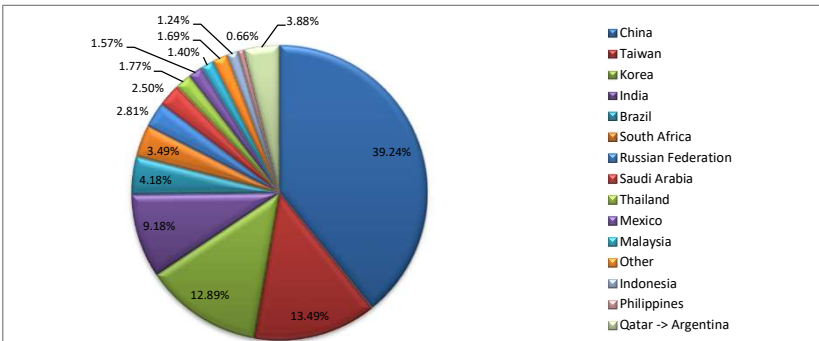
Product Description

Sector Allocation

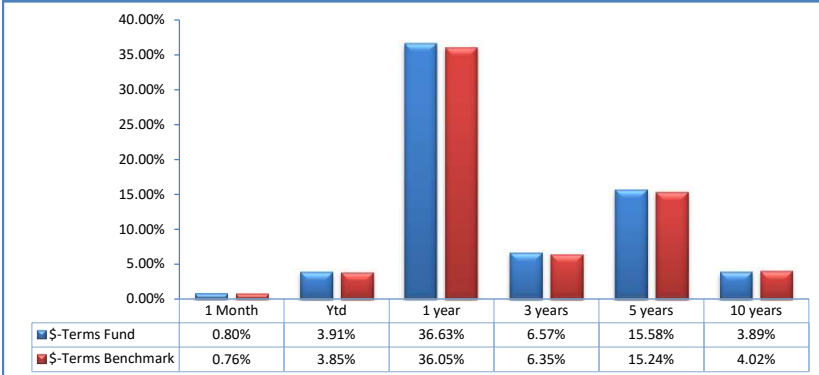


Country Allocation

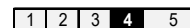
