

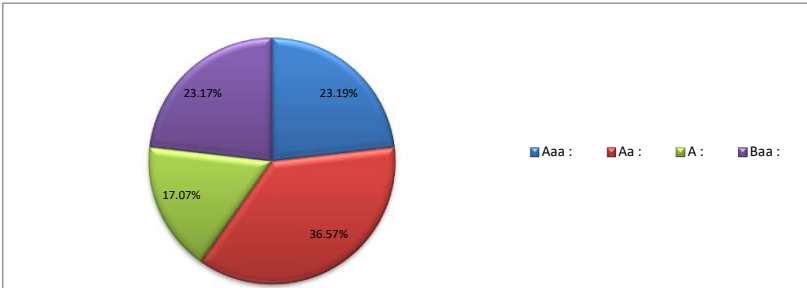

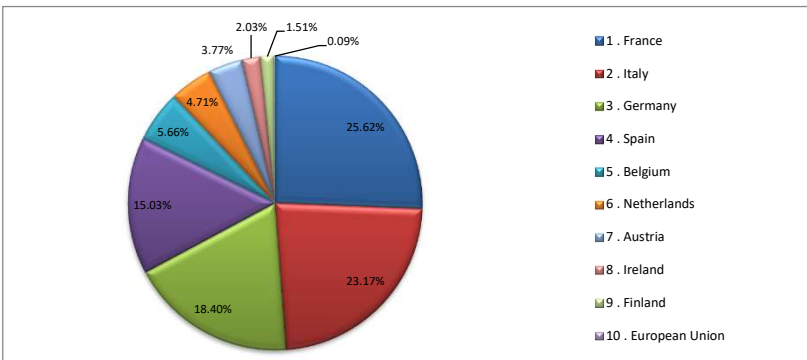
Product Description
