

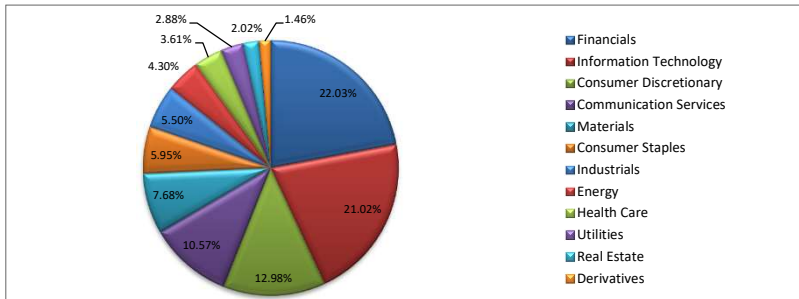

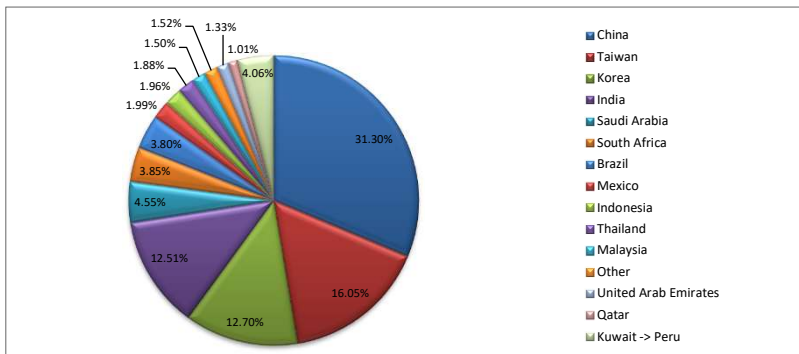
### Product Description
