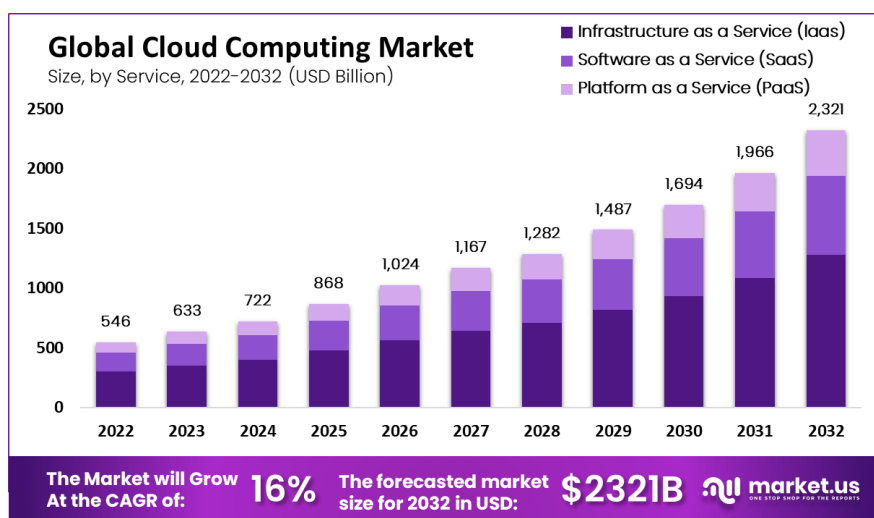

- Digital Tech Revolution converging around Cloud Computing.
- Cloud underpins Online Streaming, Gaming, Mobile, & Cybersecurity.
- Large \$75bn Microsoft-Activision Gaming deal pending - based on Cloud & Social Media usage.
- AI services ChatGPT & BARD – now integrated into Cloud services by Microsoft/Azure, AWS, Google & Oracle.
- 50% of Corporate IT spend expected to move to the Cloud by 2025.
- \$1tn new #CloudRevenues expected within 3yrs. (see chart).
- Just 25% of corporate workloads in the Public Cloud – huge upside.
