

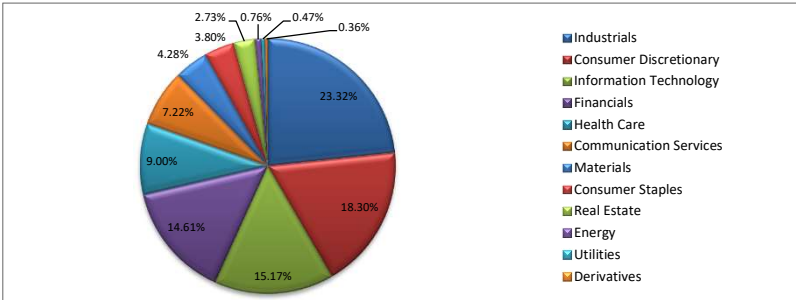

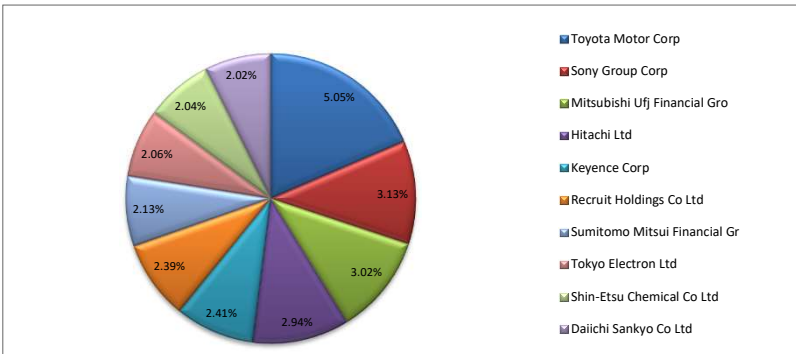
## Product Description

Forward pricing is used and funds are valued on a daily basis by no later than 17h00. Performance is quoted in US dollars or Euro terms, depending on the denomination of the Fund.
