

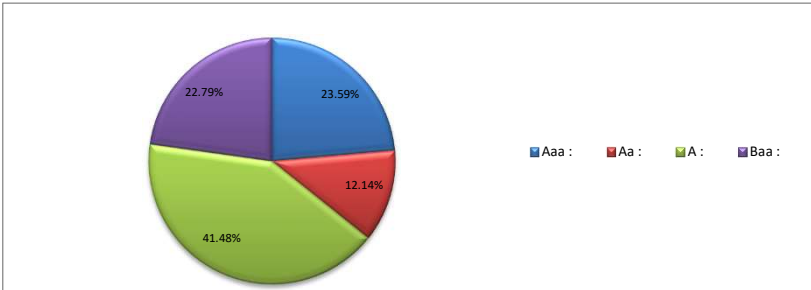

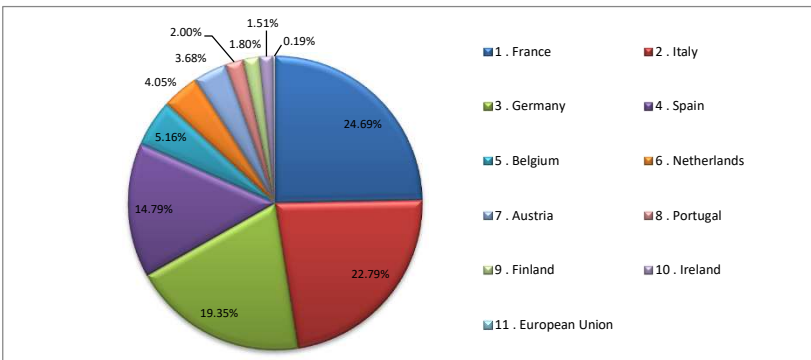
## Product Description
